## STEVENS COUNTY SHERIFF'S OFFICE TAPE RECORDED DEFENDANT'S STATEMENT

This is a Stevens County Sheriff's Department tape-recorded defendant's JC statement. This is the statement of Jeffrey S. Cunningham. The date is November 3<sup>rd</sup>, 2000. The time is now 1752 hours. I am Sgt. Jim Caruso of the Stevens County Sheriff's Department. This statements being recorded at the Fort Lauderdale Florida District Office of the DEA. There are three persons present in the room. For the purpose of voice identification would each person present please identify themselves? DB Detective Dave Baskin Stevens County Sheriff's Office. **JSC** Jeff Cunningham. Okay, Jeff, you understand this statement's being recorded? JC **JSC** Yes I do. JC Okay, would you give your full name and spell it please? **JSC** Jeffrey Stephen Edward Cunningham. **JEFFREY** STEPHEN EW...EDWARD CUNNINGHAM JC Okay, would you give your address please? I only know my address that's on my license. JSC JC And what's that...? **JSC** It's ugh... 3821 Southeast Harrison Street Portland, Oregon... JC Okay, and the address that you're... the street that you're living on here...? Ugh... Southwest 10<sup>th</sup>... or Southeast 10<sup>th</sup>... **JSC** JC Ugh... would you give your home telephone number...? JSC I don't know it.

- JC Would you give your work telephone number?
- JSC I don't know that either...
- JC Would you give me your date of birth...?
- JSC 05-17 of 75.
- JC Now you must understand your constitutional rights before we ask you any questions. Your constitutional rights are as follows:

You have the right to remain silent. Any statement that you make can and will be used as evidence against you in a court of law. You have the right at this time to an attorney of your own choosing and have him or her present before and during questioning or the making of any statements.

If you cannot afford an attorney, you are entitled to have one appointed for you by a court without cost to you and have him or her present before and during questioning or the making of any statements. If you decide to answer questions now without an attorney present, you'll still have the right to stop the questioning at any time until you talk to an attorney.

You have the right to exercise any of the above rights at any time before or during any questioning and the making of any statement.

Do you understand each of these constitutional rights as I've explained them to you?

- JSC I do.
- JC Are you willing to sign the form at this time acknowledging your constitutional rights have been read to you?
- JSC I am.
- JC And are you also willing to waive your constitutional rights at this time and sign such a waiver on this form?
- JSC I am.
- JC Okay, I'm now showing you... would you read this please for me... out loud...
- I have read or have had read to me above explanation of my constitutional rights and I understand them. I have decided not to exercise these rights at these time. Any statement made by me... made... made by me are made freely, voluntarily, and without threats or promises of any kind.

- Okay, now I'm gonna have you sign right there where it says defendant's signature. All right... Detective Baskin if you could sign where it says witness. Okay, the date is still November 3<sup>rd</sup>, 2000. The time is now 1757 hours and we're still in Fort Lauderdale.
- DB Okay Jeff, why don't you go ahead and start out ugh... with this statement a...
- JC Before we start just let me ask one more thing. Understanding these rights, are you making this statement freely, and voluntarily without any threats or promises of any kind?
- JSC Yes.
- JC Okay, go ahead...
- DB Yeah Jeff, why don't you go ahead and start ugh... with ugh... when you came to the ugh... cabin at Crown Creek...
- JSC Came to the cabin in the spring of 99 with a friend of mine... my partner, Maija, at the time and ugh... I lived there for about a year and... and ugh... and some months after that as well...
- JC Who told you you could come up there...?
- JSC Alli Walker...
- JC Okay, I'll need to have you speak up a little bit if you could...
- JSC Allright... Alli Walker...
- JC Okay, and what made you go up there...?
- JSC We just wanted ta move out to the country.
- JC Okay, did anybody else want you to move up there...?
- JSC Yeah... the family wanted me to move up there ta grow some marijuana and get ugh... connection through Canada for cheap pot.
- JC Okay...
- DB And Maija is a ugh... was your girlfriend at the time...?
- JSC She was...

- DB Okay...
- JC What's Maija's last name...?
- JSC Soucie...
- JC Okay...
- DB Did... did ya get a marijuana crop going...?
- JSC No...
- DB Did you get a connection...?
- JSC Yes...
- DB For the marijuana through Canada...?
- JSC Yes...
- DB And who was that with...?
- JSC It was through a family that lived on the hill as well...
- DB The hill... you mean the hill by...
- JSC (Not able to understand one word-covered over)...
- DB By Crown Creek...?
- JSC Yes, on Crown Creek...
- DB How'd ya get to know these...? This family...?



- JSC I was introduced to them by a neighbor of mine...
- DB And who was that...?
- JSC Dane...
- DB Okay, that would be...? Do you know what Dane's last name is...?
- JSC Williams...
- DB What is it...?

- JSC Williams...
- DB Williams... How much marijuana were you movin'...?
- JSC Quite a bit...Ugh... at first it started out small with just a couple pounds and then it got a little larger each time... workin' it's way up to anywhere between ten to twenty pounds.
- DB Okay...
- JC Would anybod... come... would anyone ugh... come up out of Portland and pick that up...?
- JSC Yes...
- JC Who...?
- JSC Rob or Shadow or Noel...
- JC Can you tell us Rob's last name...?
- JSC Schultz...
- JC What about Shadow...? What's his name...?
- JSC Ruson Hill...
- JC Ruson Hill...?
- JSC Yes.
- JC Okay, have you talked to Dane lately...? Dane Williams...?
- JSC No.
- JC Do you know who Chewy is...?
- JSC Yes.
- JC What's his name...?
- JSC John Grange...
- JC Okay, did he ever come up to the cabin...?
- JSC Yes, he lived with me up there for about a month.

- JC Okay, what... when was that month...?
- JSC In the fall of ugh... of... of the... of this year.
- JC Okay, and ugh... the fall of this year meaning 19 'er of ugh... 1999...?
- JSC No. 2000...
- JC Okay... okay, let's back up now for a minute... we're in November of 2000 right now...
- JSC Okay...
- JC Okay...
- JSC I'm sorry... I'm really scared man... I'm just... I'm really scared...
- JC That's all right... just ... just try and think... when d... when did Chewy move up there with you...?
- JSC In the fall of 99...
- JC In the fall of 99... okay...
- DB Did he just come to visit then or did he actually move in and live with you then...? Earlier conversation that uph... you said that he moved up about three weeks before the Barter Fair in June...
- JSC Right... he just came to visit... he... he came up there a couple times... like twice to visit...
- JC In the fall of 99, did he come up there to visit...?
- JSC Yeah...
- JC When did he move up there ta... ta start livin' with you?
- JSC Umm... in... in April maybe... maybe in... in May...
- JC May...?
- JSC Yeah, May...
- JC And that would have been May of...?

- JSC 2000.
- JC 2000. Okay, so he was there before the Barter Fair...?
- JSC Yes.
- DB How was it that Chewy came up there to live...?
- JSC He asked if he could come up there... I was asked if he could come spend time up there with me...
- DB Who asked you if...? If Chewy could come live with ya...?
- JSC Rob...
- DB Rob...?
- JSC Yes...
- DB Okay, how long had you know'd... known Chewy before that...?
- JSC About a year...
- DB Okay, did you know what ugh.... Chewy did...?
- JSC Yes...
- DB And what was that...?
- JSC He would collect money for people...
- DB Who'd he collect money f... for...?
- JSC Rob... He also had a job... like a... a regular job...
- DB Okay...
- JC Doing what...?
- DB What kind of a job was that...?
- JSC Ugh... he worked for Tuff Sheds...
- JC Okay...

JC Okay, you mentioned the name of Scratch... now is Scratch also known as Sasquatch...?

JSC Yes...

JC What's Sasquatch's name...?

JSC Christopher Willuweit...

JC Okay, after the party at Dane's Hamlett Road cabin, what... where did you go then...?

JSC We went to a Barter Fair...

JC Okay, did you go... you had said earlier that you thought you went down to Portland briefly...?

JSC That was after the fair...

JC Okay...

DB And ugh...

JSC Oh wait...

DB (Covered over-not able to understand one word)...

JSC The party was just after the fair and then I went down to Portland briefly...

JC Okay, so the party was in the fall...

JSC Mmm...

JC Of 99...?

JSC Yes...

JC After that then... after the party you went back to Portland...?

JSC Yes.

JC Did anyone stay at the Crown Creek cabin while you were down in Portland...?

JSC Yes, ugh... Josh and Stephanie... — NOT JOSH SCHAEFER

JC Okay, do you know their last names or anything...?

- JSC I don't... I...
- JC You ugh... when did you come back up to the area...?
- JSC Ugh... the turn of the year... New Years Eve...
- JC Okay, how did you get back up here...?
- JSC I rode up with some friends...?
- JC Do you remember who...?
- JSC No... Jacqueline and ugh... I don't remember her... the fella's name...
- JC Where did you go when you got back up to the area...?
- JSC We went ta... my cabin on Crown Creek... Lou Ash's CABIN
- JC Is that where you lived then...?
- JSC No, I... I lived over at Dane's for awhile.
- JC About how long did you live at Dane's...?
- JSC About ninety days...
- JC Where did you go after you left Dane's...?
- JSC Back to my cabin...
- JC That'd be the Crown Creek cabin...?
- JSC Yes...
- JC When were... did you live with Josh and Stephanie or...?
- JSC No, they left when I moved back...
- JC Okay, do you know why they left...?
- JSC They got another place on Kelly Hill...
- JC All right... At that time, when this was going on ugh... did Josh say anything about being in trouble...?

- JSC He said he got in trouble once for taking an ATM down a middle of a road tied to a back of a pickup truck...
- JC Okay, so you moved in... back into the...
- JSC Mmm...
- JC Crown Creek cabin and lived by yourself at that time...?
- JSC Yes.
- DB Where'd Maija go...?
- JSC She left with some guy...
- DB Okay, so you were no longer boyfriend... girlfriend at that point...?
- JSC No.
- DB Okay...
- JC We had a Barter Fair then in June...?
- JSC Yes.
- JC When did ugh...? You first go down to that Barter Fair...?
- JSC On Saturday mornin'... (too low to understand)...
- JC About what time...?
- JSC I don't know... it was like right in the... right in the beginnings of the afternoon...
- JC Did ya see anybody there you knew...?
- JSC Yes, I saw Nick...
- DB Nick Kaiser...?
- JSC Yes.
- DB Was Nick with anybody else...?
- JSC Yes, he was with a fella named Josh...

JC This was a different Josh obviously than Josh and Stephanie...? **JSC** Right... Did you know Nick was coming up to the fair...? JC **JSC** No. DB: How long it'd been since you seen Nick...? Seven... maybe eight months... DB -When you saw Nick was he happy to see ya...? **JSC** Yes. JC Did he seem afraid...? **JSC** No. JC Did he seem upset...? **JSC** Mmm... Not largely no. JC Okay, did Chewy go to the Barter Fair with you that morning...? **JSC** Yes. JC Was he with you when you saw Nick...? **JSC** No. Where was Chewy...? JC **JSC** He was off doin' somethin' else... he was workin' the gate for awhile... JC Workin' the front gate at the Barter Fair...? **JSC** Mmm hmm... Did you tell Chewy that Nick was at the Barter Fair...? JC

After I talked with Nick I... I did... yes...

What did you do...?

JC

- JSC I said that Nick was here...
- JC And why did... why did you think that Chewy would be interested in knowing that Nick was there...?
- JSC He... Nick got some people in trouble in Portland and ugh... the people in Portland asked if we were to see Nick to please have him leave the lot...
- DB Leave what...?
- JSC The lot... the fair...
- DB Who asked ya that...?
- JSC Rob...
- JC Did he tell you why he wanted Nick to leave...?
- JSC Cuz he got arrested selling LSD in Seattle...
- JC Did he say...? Did Rob say anything to you about anybody wanting harm to come to Nick...?
- JSC He told me that there was some kids in San Francisco that wanted Nicky dead... yes...
- DB The kids from San Francisco... Who would that be...?
- JSC I don't know who they are...
- DB Uh... I mean just generally... were they members of ugh... members of this family...?
- JSC Ugh... the... the broader view... yes...
- DB Okay, and why...why would the kids in San Francisco want Nick dead...?
- JSC He was making acid for them... largely supplying the west coast...
- DB And acid... you mean LSD...?
- JSC Yes...
- DB Okay, Nick was making the acid for this family and he got arrested and was... why was he in trouble for that...?

- JSC Umm... I don't understand...
- DB Well if he was makin'... makin' LSD for the... this family and got arrested over on the coast and you said he got other people in trouble because he was makin' LSD...?
- JSC Right...
- DB What ugh... what did Nick do to get those other people in trouble...?
- JSC He cooperated with the law...
- DB Okay, so he was... he was... I guess for no better terms ugh... a narc...?
- JSC Yes.
- DB Okay...
- JC All right now you had mentioned a name of Shadow ugh... Was Shadow a part of the family...?
- JSC Yes.
- JC Did he work with Rob, who you said was part of the family...?
- JSC Yes.
- JC Now what was... was Shadow in charge of...?
- JSC Money...
- JC And what was Rob in charge of...?
- JSC Drugs...
- JC Okay, and you think they both still live in the Portland area...?
- JSC Yes.
- DB What did Rob tell you about Nick...?
- JSC He said not to hang out with him... I'd be ostracized from the family just as he was...
- DB As Nick was...?

- JSC Yes.
- DB Did ugh... Rob ever say that you could also get killed if you hung out with Nick...?
- JSC No.
- DB What he tell ya about hangin' out with Nick...? Just wasn't a good idea...?
- JSC Yeah, he said that no matter how much I loved him, I had to stay away from him because he screwed up and he's in a lot of trouble and a lot of people are, you know, not happy with him.
- DB Did... Did you know that ugh... Nick was gonna be at the Barter Fair...?
- JSC I did not...
- JC As soon as you saw Nick what did you... what did you say to him...?
- JSC I told him to leave because he might be in danger...
- JC Did he ask why...?
- JSC Yes.
- JC What'd ya tell him...?
- JSC I told him because of the whole thing that happened when he got arrested and that... that nobody wanted him to be around the family places anymore because they all thought that he was workin' with the police...
- JC So what did Nick say when you told him he needed to leave...?
- JSC He wanted to met Rob instead and smooth things over and try and make it right...
- DB Had... Had Nick and Rob known each other before...?
- JSC Yes.
- DB So he wanted to meet with... with Rob and just try to work out the problem...?
- JSC Yes...
- JC Where did he want to meet Rob...?

**JSC** Up at the Barter Fair or in Portland... He was willing to go anywhere to meet him. JC Okay... Was Rob at that Barter Fair ...? DB Not that I knew... and... I knew he was in Portland... **JSC** DB Okay... JC All right so when ugh... when did Chewy find out that Nick was at the Barter Fair...? JSC I told him after I spoke with Nick for awhile... JC Was Chewy still at the gate...? JSC Yes... JC Did ugh... at any time did you introduce Chewy ta Nick...? **JSC** No, Chewy walked by on his own in the later end of the... of the day... JC Were you with him...? **JSC** Yes. JC What did he say...? **JSC** Told him to leave... JC Told who to leave...? JSC Nick... JC Who told Nick to leave...? **JSC** Chewy... JC Chewy told Nick ta leave...? JSC Mmm hmm...

And what did Nick say ...?

- JSC He didn't say anything... I think he was too high to even know... I think he just wanted a meeting with Rob...
- JC Did Chewy ever ask you if that was Nick's black Bronco or gray Bronco...?
- JSC Yes.
- JC What'd ya tell him...?
- JSC I told him it was...
- JC And isn't that then when he went up and told Nick to leave...?
- JSC Yes, I assume that's what he said... I didn't walk up to the truck with him...
- JC He went up and said somethin' to Nick...?
- JSC Yeah...
- JC Did you spend the night at the Barter Fair...?
- JSC I did...
- JC Saturday night...?
- JSC I did...
- JC Did you spend the night with Nick...?
- JSC No.
- JC Where did you stay...?
- JSC I spend most of the night underneath the stage playing music...
- JC Okay, Nick and Josh weren't there...?
- JSC No.
- JC You didn't see 'em anymore that night...?
- JSC No.
- DB Did you ever directly tell Nick that the kids from San Francisco wanted him dead...?

- JSC No, not in those direct words... (couple words covered over-not able to understand)...
- DB What'd ya tell him...?
- JSC I told him that those kids maybe... that they wanted him for... for what was happenin'...
- DB Wanted him... meanin' what...?
- JSC Like... I don... like they wanted... they wanted to know where he was... wanted to know what he was doin'...
- JC Sunday morning ugh... when you got up, did you see Nick anymore...?
- JSC Yes.
- JC What hap... Tell me about...
- JSC Nick offered me to go ta California with him and Josh and if we can go get a five lot of mushrooms to go work... I agreed...
- JC Did you tell Nick to leave Sunday morning when you were talkin' to him...? Did you ever tell him that he needed...?
- JSC Yeah, I told him that he needed to leave and just disappear and just get out...
- JC Now was this before or after the conversation of the mushrooms...?
- JSC This was before...
- JC Okay...
- DB You said earlier that you went to Northport...
- JSC Yes.
- DB Near the Barter Fair on Sunday mornin'... what'd ya go there for...?
- JSC To call Rob to see if he wanted ta meet with Nicky...
- JC Who was with you when you went to Northport...?
- JSC Dane and Chewy...
- JC Dane and Chewy...?

- JSC Mmm hmm...
- JC Where did you go to make the call...?
- JSC The gas station...
- JC Tell us about the call...? Who...? Who initiated the call...?
- I called Rob and I told him that Nicky wanted to meet with him and he said, "No way... Get... Get him outta there... Get... Get ugh... Get outta there... You shouldn't be hangin' out with him..." And ugh... you know... I shouldn't be hangin' out with him and I'm gon... I'm gonna... I'm gonna be just as ostracized from the family as he was if I kept... if I tried ta stick up for him...
- JC Did ugh... Dane talk to Rob on the phone...?
- JSC No...
- JC Did Chewy talk to Rob on the phone...?
- JSC Yes...
- JC What did...? What happened there...?
- JSC I don't know... I d... I wasn't on the phone...
- JC Did you...? Did Chewy say anything to you...? How long was Chewy on the phone with Rob...?
- JSC Oh maybe five... ten minutes...
- JC Did Chewy say anything to you when he got off the phone...?
- JSC When we were drivin' back up to the fair, he asked if I'd bring Nicky out to the cabin...
- JC Did he say why...?
- JSC He wanted to confront him... he... like that's what I assumed...
- JC Did you think that he was gonna kill Nick...?
- JSC I didn't think he was gonna kill him...
- JC What did you think he was gonna do...?

- JSC Intimidate him to get information out of him of what he said...
- JC Had you ever seen Chewy intimidate anybody...?
- JSC Only me...
- JC Did he used ta pick on you a little bit...?
- JSC Not too much... just like jumpin' around and stuff...
- JC He asked you to bring him back up to the cabin...?
- JSC Yes.
- JC Did he tell you when...?
- JSC When we got back to the fair..?
- JC Okay, and did Dane have any part in any of this as far as...? Did he tell...? Give Dane any instructions...?
- JSC Not that I knew of...
- JC So what happened when you got back to the Barter Fair then where did Chewy go...?
- JSC Chewy we... went back ta workin' the gate and I went over ta Nicky's truck and he wanted ta leave ta go get the mushrooms.
- JC Did you tell him where the mushrooms were at...?
- JSC Yes.
- JC Where did you say they were...?
- JSC In the cabin, we had to go out there to meet the fella...
- JC Did he wanta know who it was that he was gonna be meeting...?
- JSC Yes.
- JC Who did you tell him...?
- JSC I told him that we'd be meetin' Papa...

- JC Whose Papa...?
- JSC Papa Smurf... He's this fella that lives out there...
- JC Have you bought mushrooms from Papa Smurf before...?
- JSC Yes.
- DB Had you...?
- JSC Yes.
- DB Okay...
- JC What was gonna be the plan as far as Nick knew...? What... were you guys gonna go buy mushrooms and then what...?
- JSC Leave...
- JC And go where...?
- JSC To California...
- JC Did Nick think that you were gonna go with him back to California...?
- JSC Yes, I was gonna go with him back to California...
- DB What were you gonna do in California...?
- JSC We were gonna sell the mushrooms and make some money...
- JC But there really wasn't any mushrooms...?
- JSC Oh there was mushrooms...
- JC There was mushrooms...?
- JSC Mmm hmm...
- I thought that... that you had just told him that to get him to come up to the cabin...
- JSC No, there is mushrooms there...
- JC So you were going to try and do a mushroom deal then and that's wh... when was that gonna happen...?

- JSC That same day when we got there... he only lives a few miles from the cabin...
- JC Had you called Papa Smurf ta... ta see if he had anything to sell...?
- JSC Naw he doesn't have a phone...
- JC So you were just gonna go up there...?
- JSC Mmm hmm...
- JC Okay, so you were gonna go back ta California and you guys were gonna do... you knew that Chewy wanted him up at the cabin...?
- JSC Yes.
- JC You didn't know why other than what you've already said...
- I knew he wanted to confront him for what happened and, you know, ask him why... you know, wh... what was happening and why he did, you know, what was happening with all that and what he might of said to the cops or agreed to work with the cops or whatever... I don't really know.
- JC Did you think that there was a chance that Nick could get killed up there...?
- JSC I didn't think that Chewy was gonna kill Nick... No...
- JC What time did ya leave the Barter Fair...?
- JSC In the afternoon...
- JC About what time...? If you had to guess...?
- JSC After lunch... like one ish...
- JC Okay, and who all left...?
- JSC I rode with Nick and Josh in their truck...
- JC Okay...
- DB What all was in the truck when you left...?
- JSC Tank a nitrous...
- DB What else...?

- JSC A mattress...
- DB They have personal belongings in there...?
- JSC Umm... not many...
- You drove up to the cabin with Nick and Josh and they were under the impression you were gonna go up and be able ta get a five lot of mushrooms...?
- JSC Yes.
- DB When you left the Barter Fair, where was Chewy...?
- JSC He was at the gate...
- DB Okay, and did you go directly to the cabin...?
- JSC We stopped to get fuel at the bottom of the hill...
- DB In Northport...?
- JSC Yes.
- DB Okay, you didn't see Chewy go by...?
- JSC No.
- DB Okay, what'd ya think was gonna happen at the cabin...?
- I thought Chewy would intimidate J... intimidate Nicky ta tell him, you know, what he mighta said to the cops or, you know, tell him ta get outta here... stay away from the family and just ta disappear... I didn't... I don't know... that's what I thought...
- DB Okay...
- You got to the cabin, drove up ta... drove up the driveway and what did you do at that point when you got out of the rig...? First of all were there any other rigs parked there that you could see...?
- JSC Not that you can see when we pulled up...
- JC All right... so what'd ya do then...?

- JSC I walked over to the side of the house to go to the bathroom and I saw Chewy's truck...
- JC Okay, and that would be the side of the house toward the... the... like the shed... the big shed...?
- JSC Yes.
- JC Was Chewy in the vehicle...?
- JSC No.
- JC Was he anywhere around the vehicle...?
- JSC No, not that I saw...
- JC You hadn't... couldn't see him anywhere on the property...?
- JSC I didn't see him anywhere...
- JC Okay, so after that what happened...?
- JSC I went back and we went up... down near the porch to smoke a cigarettes...
- JC The bottom of the stairs...?
- JSC Yes.
- And ugh... we were smokin' a cigarette... and ugh... Nicky wanted... asked if we could do some shootin'... cuz we saw the shells everywhere and I was like, you know, all right and I went upstairs ta see if my rifle was there, but it wasn't and then came back down and ugh... ugh... I offered 'em somethin' ta eat instead...
- DB What kinda rifle were you lookin' for upstairs...?
- JSC Twenty two semi automatic...
- DB Can you describe it a little better...?
- JSC Ten clip with a wooden stock...
- DB Okay, have a scope on it...?
- JSC No.

- DB How come there was shells all over the ground...?
- JSC I shoot golf balls out in the front yard...
- DB Just for target practice...?
- JSC Mmm hmm...
- DB Okay, where did that twenty two come from...?
- JSC That was traded ta... from Josh and Stephanie...
- DB Okay, what'd ya trade for...?
- JSC Chain saws ugh...
- DB Okay, where was it usually kept...? That twenty two rifle...?
- JSC Upstairs on a shelving between two rooms...
- DB And when Nick wanted to shoot you went up there and you couldn't find it...?
- JSC No.
- DB Did it seem odd that it was gone...?
- JSC Yes.
- DB Okay, you offered 'em somethin' ta eat... what'd ya offer 'em...?
- JSC Macaroni and cheese...
- DB Okay, did you have runnin' water at the cabin...?
- JSC No.
- \*\*\*Background noise heard-possibly from hallway or another room
- DB Where would ya have got the water to ugh...?
- JSC From the creek down in front of the cabin about a hundred... two hundred yards...
- DB Okay, what ugh...? What happened from there...?
- JSC Well as I was... walkin' down to get water Dane came walkin' across the lawn...

- DB Dane Williams...?
- Yes, and we... we walked... he... he stood there and talked ta Nicky and Josh for a minute and I kept goin' down to the creek... I filled up my pot with water and started to walk back up and Dane met me at the top of the trail and he said, "Chewy's underneath the house and it is gonna happen right now."
- DB Did you know what he meant by...? "It's gonna happen right now."
- JSC Once I heard the shots, I knew...
- DB Okay...
- JC Backin' up for a minute, when ugh... when Josh and Nick were there and you were getting water... where were they standing...?
- JSC In the fire, like right around the fire pit...
- JC Had they started a fire...?
- JSC They had...
- JC A big fire...?
- JSC Naw, it was just a twig fire to get the... get it goin'... get some coals so we can cook...

- DB Where was Nicky at...?
- JSC He was layin' in the fire pit...
- DB Where was Josh...?
- JSC Right next to him...
- JC Were either one of them moving at all...?
- JSC No.
- JC Did you see Chewy...?
- JSC Yes, he was standin' there with the ri... rifle...
- JC What did he...? How was he acting...?
- JSC He had that far off glance...
- JC You'd called it earlier... "A thousand yard stare"...
- JSC Yes.
- JC Were the bodies laying...? Or what position were the bodies laying...?
- JSC On their sides...
- JC You said you ugh... were washing Nicky's face...?
- JSC Yeah...
- JC What do ya mean...?

- JSC It was in (Not able to understand)... the ashtray...
- JC Where was the pipe...?
- JSC In the glove box...
- JC Okay, what else did you get....?
- JSC Ugh... that was it...
- JC Just a pipe and...
- JSC And a... a pen... a writing pen...
- JC A writing pen... where was that at...?
- JSC That was also in the glove box...
- JC Okay, did you get any money...?
- JSC No.
- JC Did you guys go through Nick or Josh's pockets...?

- JSC When they were in the front lawn, yes...?

- JSC Yes...
- JC Who all went on those...?
- JSC Ugh... Rob and I and Sha... and Shadow and Chewy and Dougie and Amy and Annie and Noel and Jenecka and just a whole bunch of people...
- JC So did you know ugh... was Nick's... did you know Nick's girlfriend...?
- JSC Yes.
- JC What was her name...?
- JSC Loki...
- JC Okay, did you know...? Was she involved in this at all...?
- JSC I have no idea... I... they put her ta... in some safe house somewhere...
- JC Who did...?
- JSC From what I understood, Rob...?
- JC Did you know why he would have put her in a safe house...?

- JSC Cuz he was scared that the kids from San Francisco were lookin' for her...?
- JC Okay, and she was involved in this thing with Nick...?
- JSC Mmm hmm...
- JC You went on tour and how long ugh... when did the tour end...?
- JSC Ugh... umm... about five months ago...
- JC Where were you when the tour ended...?
- JSC Deer Creek...
- JC Deer Creek where...?
- JSC Indiana...
- JC Mmm okay... where ugh... you had mentioned that you had continued to sell dope for Rob...?
- JSC I tried to...
- JC Where was that out of...?
- JSC Denver...
- JC How would you get it...?
- JSC He'd send it to me in the mail...
- JC And then you'd go sell it...?
- JSC Yes.
- JC Why did that end...?
- JSC Cuz I had no money and I couldn't afford ta pay my bill... like my rent... I was living with someone that I met on tour and I couldn't afford to pay my rent... so I spent the money on pa... on my rent...

- JC Okay, I wanta go over a couple of things ugh... one thing was the gun... you said you had a cabin gun that was a twenty two with a wooden stock...?

- JC Was that the gun that was used to kill Nick and Josh...?

- JC Where did that gun come from...?
- JSC Mr. Grange came up to see Chewy...
- DB Is that Chewy's dad...?

- JSC I don't know...

- JC Why is it that if you already had a twenty two up there... why was it, do you think, that, you know, if Chewy was havin' his dad buy him things why in the world did he have him buy him a twenty two when you guys already had one...?
- JSC Cuz when you go huntin' it's good to have your own gun...
- JC Okay, did you...? Have you hunted a lot with a twenty two...?
- JSC Yes...
- JC What do you shoot...?
- JSC Pheasant...
- JC Okay, what'd the gun look like...?
- JSC It was black with a ten clip... semi automatic... all black...
- JC Do you know what kind...?
- JSC No.
- JC Did you ever touch it...?
- JSC Yes.
- JC Did you touch it the night of the homicide...?
- JSC No.
- JC Did you ever pull the trigger in the homicide...?
- JSC No.

- JC Did you ever help bury the gun...?
- JSC No.
- JC Do you know where the gun is...?
- JSC I don't...
- JC Another point I wanta cover...is the garden hose... there was a garden hose that was found... huh... did you at any time attempt to siphon any gas through a garden hose...?
- JSC No.
- JC Did you ever attempt to cut a piece of garden hose so it could be siph... so you could siphon gas out of the... outta Nick's Bronco...?
- JSC No.
- JC At any time did you see Dane Williams try and cut a piece of hose or do any siphoning with garden hose...?
- JSC I didn't see him do it, no...
- JC Did he ever mention you should...?
- JSC He said we needed ta finish it somehow, but I don't know if he did or not... I don't know...
- DB Is that when just you and him were up there or...?
- JSC Yes.
- DB Or when all three of you were up there...?
- JSC When him and I were up there...
- JC Did you ever see a green garden hose in the rig or outside the rig...?
- JSC In the rig, is... they used it for the nitrous tank...
- JC Okay, did you ever...? Did you take it out of there that night...?
- JSC No.
- JC Okay.

- DB Did you and Dane try to burn that rig before you left the first time...?
- JC No.
- DB You didn't make any attempt to light it on fire...? Stickin' a... somethin' ugh... in the spout for the gas... lightin' it or try and siphon gas out so you get gas inside the passenger compartment and burn the rig before... before Chewy come back up...?
- JSC I didn't do anything like that... I don't know if Dane did or not, but I know I... I didn't...
- DB Why would you... why would you dig around in your... in your friends Bronco after he's dead... you drove it up to the top of the hill and you... you dig around in there and steal his... his pot pipe and his pot from him...? You know, it... it...
- JSC Cuz those are the only two things I saw that were like ceremonial and I felt bad for what happened... so I wanted to do some... somethin'...
- DB So you were gonna smoke a little pot as a ceremony ta... for your dead friend and his buddy...?
- JSC No, I didn't smoke it... I just threw it away...
- DB Why ugh... why were they goin' through the pockets of yer... of yer friend there in the lawn...? Were you doin' that or who was doin' that...?
- JSC Dane checked the pockets of Nicky... I don't know if he checked the pockets of Josh or not...
- DB How'd you feel about that...? Your friend that your all worried about... cryin' over... washin' blood off his face and this other guy's goin' through his pockets?
- JSC Thought it was kinda greedy...
- DB You say anything to him about it...?
- JSC No.
- DB You just went along with it...?
- JSC Yeah...

- DB Why didn't you guys just leave Sunday...? You got everything all packed up in the Bronco... you've done yer... you've done yer thing... you burned the... burned the bodies... why didn't you just leave...?
- JSC I spent the night with Maija...
- DB Would you have left before if she... if she hadn't come up there...?
- JSC Yes.
- DB Was everybody agreed to that or was...?
- JSC Yes.
- DB So while your off with your girlfriend the other two guys are...?
- JSC I don't know where they went...
- DB Well they're at Dane's cabin...
- JSC That's where we left them, yeah...
- DB You left 'em there while you went off with your girlfriend and they're... they're there and you got... two bodies up on the hill in a burned out rig that... that you guys had just done this... this homicide and you go back to the very cabin where it happened and spent the night with your girlfriend...?
- JSC I did...
- JC Do you think that's one reason Chewy was upset at you the next morning was because you spent the night with Maija instead of tryin' to get out of there that night...?
- JSC Yes.
- JC Was he planning on you guys coming back shortly after you left so you guys could leave...?
- JSC I don't understand...
- JC Did...? Did Chewy think that you guys were go... just gonna go down there for a little while and then come back...?
- JSC (Not able to understand-covering over each other...)
  Ugh...

- JC Or did he know you...?
- JSC He knew...
- JC Were gonna spend the night...?
- JSC He knew we were gonna spent the night...
- JC Did that make him mad...?
- JSC Yes.
- DB Are you guys drinkin' while you're there at Dane's...?
- JSC No, not that I remember.
- DB Somebody take a bottle of rum out of the uh... Bronco...? Nick's Bronco...?
- JSC I don't remember that...
- JC Think hard, Jeff, this is very important...
- JSC Okay...
- JC A clear bottle of rum... unopened... out of Nick's vehicle...? Did you take it out when you were goin' through the other stuff...?
- JSC Yes.
- JC Do you know what kinda rum it was...?
- JSC No.
- JC Did you drink some that night...?
- JSC (Too low-not able to understand...)
- JC Did Chewy...?
- JSC I don't know...
- JC Where'd the bottle end up...?
- JSC I don't remember...

- JC What's ugh...? What's Dane or Chewy gonna say when we talk to them...? What are they gonna say your involvement was...?
- JSC I don't know ugh... they'll probably say it was my cabin and ugh...
- JC They gonna say that you pulled the trigger...?
- JSC No, I didn't pull the trigger...
- JC Are they gonna say that...?
- JSC Uhh... I don't know...
- JC Are they gonna say that you...?
- JSC I hope they tell the truth...
- Are they gonna tell us anything different than what you have...? Is anybody gonna try and tell us that you tried to set the rig on fire...?

- DB Did you siphon the gas out or tried to siphon the gas out while you were up on the hill...? Take care of it before you went back down and had to face Chewy again...?

- JC Anything else ugh... you want to add to this statement, Jeff...? This is your chance to talk...

- JC Have any threats or promises been made to you since we started this interview...?
- JSC No.
- JC At any time during this interview have you asked the questioning or taping be stopped...?

- JC At any time during this statement have you requested an attorney...?
