I. PLEA AGREEMENT

The State of Washington and the defendant, JEFFERY STEPHEN CUNNINGHAM, enter into this Plea Agreement which is accepted only by a guilty plea. This agreement may be withdrawn at anytime prior to entry of the guilty plea. The Plea Agreement is as follows:

1.1 *PLEA*: The defendant shall plead guilty to :

Appendix 1-A**

State of Washington v. Jeffery Stephen Cunningham

The Defendant, Jeffery Stephen Cunningham, is presently charged with First Degree Rendering Criminal Assistance under cause number 00-1-00188-1.

The Plea Agreement is as follows:

1. The defendant, Jeffery Stephen Cunningham, will plead guilty to First Degree Rendering Criminal Assistance in Stevens County Superior Court.
2. The defendant will provide information and answer questions of law enforcement as to the details leading up to and including the murders of Nicholas Kaiser and Joshua Schaefer, the subsequent actions of John Grange and Dane Williams including the disposal of the victims, their property and evidence of the crimes. The defendant will also provide information as to the attitude of John Grange before and after the murders. The defendant will cooperate with law enforcement up to, during and after any hearings and trials of John Grange.
3. The defendant will testify truthfully and honestly at any hearing or trial as to the fact sand circumstances surrounding the murders of Nicholas Kaiser and Joshua Schaefer.
4. The defendant has an offender score of 1 and a standard range of 12+ to 14 months. The State will recommend 12 months jail, restitution, crime victim's fund,, court costs, attorney fees and one year community supervision.
5. This agreement labeled Appendix 1-A is incorporated into and made a part of the standard plea agreement.
6. The defendant agrees to waive speedy sentencing until 30 days after the trial of John Grange.

7. State will not file additional charges after entry of plea. *JG*
